ORDER OF REFERENCE

Extract from the *Journals of the Senate* of Tuesday, March 7, 2023:

With leave of the Senate,

The Honourable Senator Gagné moved, seconded by the Honourable Senator LaBoucane-Benson:

That the Standing Senate Committee on National Finance be authorized to examine and report upon the expenditures set out in the Main Estimates for the fiscal year ending March 31, 2024.

INTRODUCTION

The Standing Senate Committee on National Finance (the committee) has an important role to play on behalf of Parliament and Canadians in examining the federal government's spending plans, as outlined in the main and supplementary estimates. The committee reviews and presents reports on the government's proposed spending in order to examine whether it is reasonable, takes into account value-for-money, will be effective in achieving the government's objectives and allows parliamentarians to follow the money.

The *Main Estimates 2023–24* were tabled in the Senate on February 16, 2023. They provide information to support the federal government's request for Parliament's approval of spending to deliver programs and services during the fiscal year 2023-24. The Main Estimates for the year ending March 31, 2024 were referred to the committee on March 7, 2023. Since their tabling, two related appropriation bills were adopted.

Voted budgetary expenditures of \$198.2 billion were requested in the *Main Estimates 2023–24*, in addition to \$234.8 billion in statutory forecasts, for a total of \$432.9 billion in budgetary expenditures, which is an increase of 8.9% from the previous year's main estimates.

In order to examine the Main Estimates, the committee held 18 meetings and questioned officials of 37 organizations that were requesting total voted appropriations of approximately \$184.9 billion, which represents 93% of the total voted amount (budgetary and non-budgetary) requested. The committee also heard from the President of the Treasury Board, the Honourable Mona Fortier, and the Parliamentary Budget Officer, Yves Giroux.

This report presents observations on the most interesting or concerning topics discussed during the examination of the main estimates.

OBSERVATIONS

 During its examination of the *Main Estimates 2023–24*, the committee heard from officials of federal government departments and agencies, who generally gave satisfactory answers to the committee members' questions. However, on several occasions, witnesses requested to provide the committee with a written response, as they were unable to provide an answer on the spot. Some written responses were not provided to the committee, others were delayed, and still others were imprecise or incomplete.

The committee wishes to remind government organizations that, when appearing before the committee, they should be represented by individuals who are best qualified to answer questions directly. If a response needs to be provided in writing, it should be complete, precise and provided by the deadline set by the committee chair. Without the necessary information, the committee cannot properly carry out its parliamentary function of scrutinizing government estimates, public accounts and reports of the Auditor General, and examining other matters relating to government finance.

2. In a context where federal organizations are asking parliamentarians to authorize increases in appropriations to operate programs, the committee expects to be able to determine the progress that has been made on achieving objectives related to the tangible results of these programs, measured with relevant indicators. However, on several occasions, officials were unable to adequately explain the progress made or to link the additional amounts requested to the achievement of measurable and specific objectives.

Federal organizations should systematically develop relevant performance indicators to make them more accountable to Parliament.

3. The committee believes that it can be very difficult to track the amounts spent on various budget measures, from the time they are announced in the federal budget to the time the amounts are requested in the estimates, then authorized in supply bills and reported in the public accounts. A striking example is the very substantial – albeit legitimate – amounts for Indigenous claims and the provision for contingent liabilities, which are not always broken down: it is difficult for parliamentarians to understand the details of the amounts requested and those reported in the public accounts.

Further efforts should be made to enable parliamentarians to better track budget spending. As well, the Public Accounts of Canada should be tabled more promptly, either by September 30 of each year, as described as an "advanced practice" by the International Monetary Fund¹, or by October 15, as recommended by the House of Commons Standing Committee on Public Accounts in 2022 "to align with the tabling date of some Canadian provinces and peers in the Organization for Economic Co-operation and Development.²"

4. In the *Main Estimates 2023–24*, voted appropriations for budgetary items have increased by 8.9% over the previous year. Budgetary expenditures for statutory items are forecast to increase by 13.3%, including a 9.3% increase in the Canada Health Transfer. These increases are not related to COVID-19 pandemic spending, which was \$40 billion in 2021–2022 and \$7 billion in 2022–2023³. As well, the number of employees (full-time equivalents) rose from 368,165 in 2018–2019 to 431,698 in 2022–2023, an increase of 17.3% and an average annual growth rate of 4.3%⁴.

The committee understands the need for increased spending in certain areas such as health care and Indigenous claims. However, it is concerned about the significant overall increase in public spending and the size of the public service, especially in the current high-inflation environment. The federal government, together with its partners such as the provinces, territories and Indigenous communities, should put in place a long-term plan to ensure greater transparency regarding the outcomes of these investments. The same can be said regarding

some existing expenditures whose effectiveness may warrant reviews in today's context, including tax benefits for the oil and gas industry.

5. Canada Mortgage and Housing Corporation (CMHC) officials were questioned about the lack of housing, especially affordable housing, and the resulting increase in housing prices.

This issue is of utmost concern to the committee. The committee expects greater efforts to be made to resolve this crisis as quickly and effectively as possible, in coordination with the provinces, territories and municipalities who play a leading role in determining affordable housing needs, financing social housing and urban planning. CMHC must also be consulted to a greater extent on all housing-related matters, including the determination of immigration targets.

6. Few details were provided on the \$15.4 billion spending review announced in the 2023 federal budget. The Parliamentary Budget Officer called on parliamentarians to provide advice and set criteria for the government so that it knows which benchmarks should guide it in its reviews.

The committee expects to be informed as decisions are considered so that it can provide its input. It also believes that such reviews should be carried out on an ongoing basis to optimize government spending.

7. The committee heard from Canada Revenue Agency (CRA) officials who, among other things, briefed on its audit work.

The committee supports the CRA in its efforts to recover amounts paid to ineligible COVID-19 program recipients; it also encourages the CRA to increase its efforts to combat tax evasion.

8. Fisheries and Oceans Canada officials indicated that funding may be available to respond to issues such as declining shrimp stocks in the Gulf of St. Lawrence.

The committee believes that Fisheries and Oceans Canada should consider providing seafood workers affected by the decline in shrimp stocks with transitional measures such as licence buybacks, or other measures such as a larger share of redfish quotas reserved for struggling shrimpers.
