

**Follow Up Request from the
Standing Senate Committee on Aboriginal Peoples
30 May 2018**

Question:

Senator Dennis Patterson (Nunavut): The consultation is to begin June 12, and you announced the advisory committee, which I hope will be helpful. I guess they must be ready to start work. I wonder, minister, if you could kindly share with the committee the names and qualifications of those selected, if it's timely....

Also, would you be able to share with the committee the names of every nation, group and organization you have invited to participate in the co-development of the consultative plan?

Answer: The Indigenous Advisory Panel is comprised of the following members:

- Stuart Wuttke, General Counsel, Legal Affairs and Justice, Assembly of First Nations
- Adam Bond, Legal Counsel, Environment, Corporate, Citizenship, Native Women's Association of Canada
- The Congress of Aboriginal Peoples is in the process of identifying a permanent member but has sent a representative to the meetings
